#### **Business Meeting**

  - O The Members voted down this proposed change that Under MEMBERSHIP, add...Membership Removal A member may be removed from the club in the following manner: Five or more members must tell the President that they wish to submit a name to be voted on for removal. The President will announce that this procedure has started. The member in question may explain or defend himself at that meeting and the next, regular monthly meeting. A vote to remove that member will take place at the next regular monthly meeting after the procedure has started. A 75% majority of those present is required to remove the member.
- Health and Well-being of members was discussed: Charlie Smith has back trouble and Mike Catt provided an update on Charlie, Wayne Chester was back at meeting after having hip replacement. Wayne expressed appreciation for the members concern and the card he received from the club, Peter Hamel requested prayer for his wife who is scheduled to have a knee replacement, John Callahan's wife is scheduled to have a tumor removed and John requested prayer for his wife.

### **Tournament Director News**

The next "one on one" will be held on December 6 from 7:00am —2:00pm. Remember to check "Breaking News" on the club web site for changes. Please bring some change for the entry fee; i.e., two 10's or a 10 and two 5's.

Rules for the "one on one":

- Tournament fee is \$20 per person of which \$5 goes to Big Fish.
- A seven hour tournament starting at Safe Light or time designated by the TD.
  - If you fish with a partner, fish must be separate at all times.
  - If you come in late, you are disqualified.
  - A quarter pound penalty per dead fish.
  - A pound penalty for a short fish.

Payout is as follows: 1—9 participants, 100%; 10—15 participants, 60% and 40%;

16 participants and over, 50%, 30%, and 20%.
